

WET'SUWET'EN FIRST NATION NOTICE OF NOMINATION MEETING

Notice is hereby given that the **Wet'suwet'en First Nation** will hold a Nomination Meeting on **April 22, 2025**, in accordance with the *Wet'suwet'en First Nation Custom Election Code (2017)*, for the purpose of electors nominating candidates for the Offices of one (1) Chief and two (2) Councillors for the ensuing term of office, in an Election to be held on **May 30, 2025**.

Registered Members of the Wet'suwet'en First Nation who are at least eighteen (18) years of age as of the date of the Election may nominate or second candidates, and vote in this Election, and shall form the Electors List.

An Elector may nominate or second the nomination of other Electors by completing a Nomination Form and submitting it to the Returning Officer by electronic transmission (such as email), mail, or in person at the Nomination Meeting.

An Elector may nominate no more than one (1) candidate for Chief and two (2) candidates for Councillor.

Nominations must be received by the Returning Officer prior to the end of the Nomination Meeting to be valid.

To stand as a Candidate in the Election, an Elector must meet the following criteria:

- Must be an eligible elector of the Wet'suwet'en First Nation who is at least eighteen (18) years old as of the date of the Election;
- Must be duly nominated and seconded by other Electors for one office (may run for either Chief or Councillor, not both);
- Must complete the Nomination Acceptance Declaration Form and deliver it to the Returning Officer within 72 hours of the Nomination Meeting (**before 8:00 PM on April 25th, 2025**).

All Notices, the Proxy Form, the Nomination Form, Official Electors List, and all supplemental documentation shall be posted and available at the Wet'suwet'en Administration Office during regular business hours and at the website:

A Speech Day for candidates shall be held on April 30th, 2025, at the Community Hall from 6:00 PM to 8:00 PM. **Candidate attendance is required.** Candidates must deliver a completed Speech Day Participation Request Form to the Returning Officer prior to the start of the meeting on Speech Day to participate.
